Acceptance of application

Acceptance of each application is subject to the physical constraints of the storage area. The decision of the Sutton Dinghy Club House & Grounds Committee is final.

Insurance/Liability:

The boat owner shall be obliged to maintain adequate insurance cover, including 3rd. party cover, of at least €1,250,000.00. Sutton Dinghy Club, its members & staff shall not be liable for any loss or damage in any event. This extends to boats & equipment, & also to persons entering the facility, or using any facilities or equipment. Boats & equipment are left at Sutton Dinghy Club at the owner's risk. A copy of the boat owner's current insurance certificate must accompany this application.

There will be no refund for an early removal of the boat from the club facility.

Over-stay penalty:

In the event that the boat is not removed from Sutton Dinghy Club at the end of the agreed storage period, the boat owner will incur a penalty of €30.00 per metre per week. Boats cannot be removed without the penalty fee being paid.

Membership:

BOAT/TRAILER PARKING AND STORAGE REGULATIONS (ISSUED 2024)

BOATS AND TRAILERS MAY BE BROUGHT ONTO THE PREMISES OF SUTTON DINGHY CLUB ONLY WITH THE APPROVAL OF SUTTON DINGHY CLUB HOUSE AND GROUNDS COMMITTEE AND IN ACCORDANCE WITH THESE REGULATIONS.

- 1 Sutton Dinghy Club accepts no responsibility for any loss or damage to private property whilst stored on these premises.
- 2 Owners are required to arrange adequate insurance for their property.
- 3 All applications for winter storage accommodation will be considered annually by Sutton Dinghy Club House & Grounds Committee.
- 4 Appropriate application forms are obtainable from Sutton Dinghy Club or from the Club website, *www.sdc.ie*.
- 5 All boat owners applying for winter storage must be a Member of Sutton Dinghy Club or have made application to be an Associate Member with their application.
- 6 Acceptance of applications will be subject to the physical constraints presented by access to the club. The decision of the Sutton Dinghy Club House and Grounds Committee is final.
- 7 Boats allocated space must occupy that space only. Boats, trailers and boat equipment not in their allotted storage space shall be removed at the owner's expense.
- 8 Boats, masts, booms, trailers, trolleys etc must bear marks of identification which will be easily recognised by the owner and Sutton Dinghy Club.
- 9 All boats, trailers and equipment must vacate the premises at the end of the agreed storage period as stated on the application form. Boats and equipment that are not removed at the end of the agreed storage time shall incur a penalty charge of €30.00 per metre per week. The House & Grounds Committee may remove all boats and equipment & charge the boat owner for all costs incurred. All penalty charges must be paid prior to the removal of the boat, trailer and equipment.
- 10 Allocation of boat space, duration of winter storage and fees shall be at the discretion of Sutton Dinghy Club House & Grounds Committee.
- 11 All winter storage fees must be paid in advance, & in full, with the application for boat parking.

- 12 All boat owners shall ensure that none of their boats or equipment shall leak any fluids onto the ground causing a pollution problem. Any boat that does, their owner shall be responsible for cleaning up same and disposing of all fluids in a safe and environmentally suitable manner. Any boat owner that does not comply shall be charged the cost for the safe removal of the waste.
- 13 A boat owner ceasing to be a Club Member (or Associate Member) for what ever reason will, within 30 days of such cessation remove their boat and other property from the Club premises and shall bear all expense incurred.
- 14 No work shall be done on the boat other than minor repairs or routine maintenance by the boat owner, crew or family members. No major work or overhauls shall be carried-out on these premises. Maintenance on the boat shall be in accordance with our health, safety & environment policy, and can only be performed between 08.00 hours and 20.00 hours.
- 15 Health, Safety & Environment: Noise from engines, radios, halyards, or any other source must be kept to a minimum. Storage of equipment must be on-board the boat & not to be left on the hard space. Refuse, etc. must not be left on the hard space. There shall be no nuisance or annoyance to any other boat owner, staff member, club member or resident in the vicinity.
- 16 Contravention of these rules may result in a refusal to permit boat parking in subsequent years.
- 17 Yacht/Boat cradle must be appropriate to size of yacht/boat so that it is safely & securely stored.
